## **EPA Updates**

#### **Good Neighbor Plan Judicial Stay Orders:**

On August 5, EPA released a memorandum describing how the Agency plans to comply with the Supreme Court's June 27, 2024 order granting applications for a stay of the 2023 Good Neighbor Plan, pending Judicial Review. The memorandum also addresses the next steps the Agency intends to undertake to ensure that states' obligations to address interstate ozone pollution under two prior rules, the CSAPR Update and the Revised CSAPR Update, continue to be met.

Indoor AirPLUS V2 Program Update: On August 5, EPA announced enhancements to its Indoor AirPlus home labeling program. These improvements are designed to advance indoor air quality protection and expand market accessibility for new home buyers. Learn More

#### **Proposed Rulemaking: Fuels Regulatory Streamlining Amendments**

**Rule:** On August 16, EPA announced a proposed rule that makes revisions, updates, and corrections to its streamlined fuel quality regulations. This action does not propose to change the stringency of any existing fuel quality standard. **Learn More**

## **2023 STAR Overview**

The National Tribal Air Association recently released the 2023 Status of Tribal Air Report (STAR). The STAR aims to provide an annual snapshot Tribal air quality and air programs nationally and is written for Tribal Leaders and Tribal environmental professionals. The 2023 STAR presents information on Tribal air quality and air programs, features an emissions data highlight, summarizes the academic literature on the health impacts of air pollution, defines NTAA's air policy priorities, requests a suitable annual budget for Tribal air programs, and highlights the important air quality work being conducted in Indian Country.

#### **Tribal Air Program Statistics**

Tribes received slightly fewer total CAA grants in 2023 (120 grants) compared to 2018 (122 grants), but the number of mature Tribal programs has grown significantly over time. Additionally, more Tribes in 2023 had approved Treatment as a State status(71), Tribal Implementation Plans, State and Tribal Indoor Radon Grants, and ambient monitoring programs than in 2018(61 Tribes with TAS).

Tribes received many non-Clean Air Act grants from the U.S. EPA in 2023. Specifically, Tribes received 90 Climate Pollution Reduction Grant planning grants, and 19 Tribes received an American Rescue Plan Enhanced Air Quality Monitoring Competitive Grant. Tribal and Territory Diesel Emissions Reduction Act grants were disbursed in 2024.

While the number of areas in nonattainment largely stayed the same nationally between 2018 and 2023, the number of areas in nonattainment in EPA Region 9 decreased from 154 to 100 from 2018 to 2023, indicating air quality improvements. Areas in nonattainment in Region 6 increased from 0 to 1, reflecting either air degradation or the NAAQS being made stricter over the six-year period.



#### **Data Feature on Oil and Natural Gas Wells**

The "Data Feature" section is a new addition to the STAR in 2023. The 2023 Data Feature highlights emissions from oil and natural gas wells, considering their prevalence on Tribal Lands in the central U.S. In 2023, 64,000 oil and natural gas wells producing up to 40 barrels of oil equivalent per day operated on Tribal Lands, almost 90% of which were marginal conventional wells (MCWs). Plugging and abandoning MCWs may significantly reduce methane emissions in Indian Country.


#### **NTAA Priority Issues and Budget Request**

The NTAA's 2023 Priority Issues were based on a survey of member Tribes and focus on three main themes: consultation, funding, and air policy. Related to funding, the NTAA determined the budget need for Tribal air programs in 2023 to be \$79 million, while the EPA's STAG budget for Tribal air programs was \$15.5 million. The EPA's STAG budget has limited the ability of Tribes to access funds for new air programs and has inhibited the maintenance and growth of existing air programs. Additionally, while IRA and ARP funds are helpful, they are one-time infusions of resources that cannot sustain programs long-term.

#### **Tribal Case Studies**

Tribal Case Studies showcase the important work that Tribal air programs conducted in 2023. The 2023 case studies cover projects focused on leveraging funding sources, engaging with Tribal communities, and more. The case studies include programs nationally, from the Keweenaw Bay Indian Community to the La Posta Band of Mission Indians.


